The 100th Day Press Charade

First 100 Days: "Foreign" Policy

After 100 days in office, President Obama has made many questionable overtures, decisions, and statements that will greatly weaken our standing around the globe in the years to come. Here are the foreign policy missteps to date:

Iraq

On February 27th, President Obama informed the enemy that the United States will be withdrawing all U.S. combat troops from Iraq by August 2010. On April 7th, the President made a surprise visit to Iraq, where apparently politics was on the front burner: "The troops were interrogated beforehand, with those military members who had voted for President Obama given identical digital cameras and placed in front of the media cameras covering the event."

Afghanistan

On March 6th, President Obama stated for public consumption that the United States was not winning the war in Afghanistan, and that he was considering talks with "moderate elements" of the Taliban.

Iran

On March 20th, President Obama released a web video reaching out to Iran, a country whose leaders regularly predict Israel's destruction. A month later, on April 20th, Iranian President Mahmoud Ahmadinejad called Israel a "cruel and repressive racist regime" at a United Nations' Conference On Racism in Geneva.

100 Days: The Mainstream Media's Love Affair With President Obama Continues

On April 27, 2009, The Center For Media And Public Affairs released a report on the media's coverage of President Obama during his first months in office.

Here are some of the findings, which confirm that the liberal media is hopelessly biased in its coverage of President Obama:

"During his first 50 days in office, the three broadcast network evening news shows devoted 1021 stories lasting 27 hours 44 minutes to Barack Obama's presidency. The daily average of seven stories and over 11 minutes of airtime represents about half of the entire newscasts. By contrast, at this point in their presidencies George W. Bush had received 7 hours 42 minutes and Bill Clinton garnered 15 hours 2 minutes of coverage, for a combined total airtime five hours less than Mr. Obama's."

"Mr. Obama has received not only more press but also better press than his immediate predecessors. On the ABC, CBS, and NBC evening news, fifty-eight percent of all evaluations of the president and his policies have been favorable, and 42 percent were unfavorable. CMPA's previous studies of network news found that George W. Bush received only 33 percent positive evaluations by sources and reporters during the first 50 days of his administration in 2001, and Bill Clinton received only 44 percent positive evaluations during his first ten weeks (70 days) in office in 1993."

"The three networks have evaluated Mr. Obama very similarly - 57% positive comments on ABC, 58% positive on CBS, and 61% positive on NBC. But he fared far better in New York Times stories, where nearly three out of four evaluative comments (73%) by sources and reporters were favorable."

These findings are extremely informative, but not in the least bit surprising. The mainstream media is saturating the airwaves with glowing coverage of President Obama. It's no wonder that everyday more and more Americans are getting their news from alternative sources so they can find out what's really going on with their government.

Saudi Arabia

On April 1st, controversy erupted as video showed President Obama apparently bowing to King Abdullah at a G-20 meeting in London.

North Korea

On April 5th, hours after the rogue regime in North Korea threatened United States’ security with a missile test, President Obama stated his intention to disarm: “Today, I state clearly and with conviction America’s commitment to seek the peace and security of a world without nuclear weapons.”

Cuba

On April 16th, Cuban President Raul Castro stated that “everything” was on the table for potential talks with the U.S. On April 17th, President Obama responded by saying that he “seeks a new beginning with Cuba.” A few days later, Fidel Castro injected himself into the discussion. According to *The Associated Press*, “Fidel Castro says President Barack Obama ‘misinterpreted’ his brother Raul’s remarks regarding the United States and bristled at the suggestion that Cuba should free political prisoners or cut taxes on dollars people send to the island.”

Venezuela

On April 18th, President Obama shook hands with Venezuela’s dictator, Hugo Chavez. Over the past several years, Chavez has made countless anti-American statements, including blaming the September 11th attacks on America.

Pakistan

On April 22nd, according to *USA Today*, “Just back from a visit to Pakistan, Sen. John Kerry says the Obama administration’s plan for that volatile country, rolled out last month with great fanfare, ‘is not a real strategy.’”

Obama Doctrine: Face Prosecution For Keeping The Country Safe?

The first hundred days of the Obama Administration was characterized by superficial attempts at bipartisanship such as inviting a couple of token Republicans over to the White House to watch the Super Bowl. These small gestures have served him well in the media which has fallen all over itself to confer an aura of “bipartisanship” onto President Obama.

For all his talk about turning the page and ending partisanship in Washington during the campaign, President Obama recently opened the door to what could potentially be the most divisive issue in the history of the nation.

With the release of previously classified memos detailing the interrogations of two high

-value al Qaeda prisoners, President Obama has introduced a dangerous notion into the political discourse in this country—the idea that officials can

Just days before reversing himself, President Obama released a statement addressing the matter which read, in part: “[t]his is not a time for retribution. It's a time for reflection. It's not a time to use our energy and our time in looking back and in a sense of anger and retribution.” His Chief of Staff, Rahm Emanuel, subsequently affirmed that declaration, saying “...those who devised the policy, he believes that they . . . should

First 100 Days: Partisan DHS

The Department of Homeland Security’s (DHS) main priority is supposed to be protecting the American people. This critically important goal requires serious leadership and a commitment to stay above the partisanship in Washington. The world sees DHS as our institutional response to the attacks of September 11, 2001, so it’s essential that its credibility is maintained. When evidence emerges that DHS could have a hidden political agenda, it can have a dire effect on the agency’s central mission.

Secretary Janet Napolitano is in charge of the Department and is responsible for its actions - good and bad. Recently, the Department released a report warning law enforcement groups about rightwing extremists as potential terrorist threats. Incredulously, the report actually defines “rightwing extremism” partly as “those that are mainly antigovernment, rejecting federal authority, in favor of state or local authority, or rejecting government authority entirely. It may include groups and individuals that are dedicated to a single issue, such as op-

position to abortion or immigration.”

Under the title “Disgruntled Military Veterans,” the report states that “rightwing extremists will attempt to recruit and radicalize returning veterans in order to exploit their skills and knowledge derived from military training and combat.”

Our federal government, under the leadership of Barack Obama and Janet Napolitano, is actually monitoring military veterans and other Americans who support states rights, are pro-life or against illegal immigration as possible terror threats! Sadly, this report smacks of a political agenda that aims to marginalize law-abiding, conservative-leaning Americans. not be prosecuted either.”

The matter seemed settled at that point. The memos were released, the information was out in the public domain, and the American people could make their own judgment. But then President Obama caved into the left and reversed himself, opening himself to the possibility that former Bush Administration officials could be prosecuted for decisions made, in good faith, to protect the country.

Some will argue that President Obama declared that he was only open to the prosecution of the lawyers that had rendered the legal opinions. There-

fore, he would not attempt to prosecute high level officials, making the issue moot. But to prosecute the lawyers for producing a piece of paper without prosecuting either the people who actually performed

the act or the decision makers who ordered the waterboarding, smacks of a disingenuous attempt to placate the left by putting someone in jail without going all the way to the top.

The American people, whatever their feelings on the act of waterboarding, will not abide a President who stoops to such a petty level. They recognize that it is fundamentally unfair to attempt to jail mid-level attorneys because the current administration disagrees with their legal opinions, while ignoring the top and bottom of the chain of command.

By reversing positions in an attempt to soothe the fringe left that carried him through the pri-

maries, President Obama has painted himself into a corner because the logical conclusion of his new position leads straight to the CIA Director’s office, to the Director of National Intelligence’s office, and back to the Oval Office.

That path also runs directly through Nancy Pelosi’s office and all of the other congressional leaders who were briefed on the CIA’s interrogation tactics and who voted to fund those activities. Will President Obama have the courage to call out those congressional leaders from his own party to the mat for their approval of waterboarding? Will the Democrat leadership own up to their complicity? Of

course not. This will be nothing but a partisan witch hunt.

Now President Obama has a choice. He can either reverse himself a second time and declare

that his administration will not engage in the kind of political retribution usually reserved for opponents of third-world dictatorships, or he can embroil the country in a divisive series of show trials that this country has ever seen.

You can be certain that once the prosecutions begin with low-level attorneys, deals will be cut and partisan pressure will be applied to force the investigations up the chain of command. Once that happens, we’re in for a long and ugly process. It appears that President Obama has started us down a very slippery slope. There is still time to stop, but he must act quickly before we, as a country, go over the edge.

First 100 Days: Partisanship Reigns in Obama’s Washington

Obama's Earth Day Hypocrisy

When will liberals learn that nobody likes a hypocrite? Just for a nice Earth Day photo opportunity in Newton, Iowa (a 2012 presidential swing state), *CBS News* reported that President Obama burned through more than 9,000 gallons of fuel to get there. You read that right. *CBS News* actually reported something negative about President Obama in his first 100 days! Mr. Obama felt it was important to make his environmentally friendly speech from a plant that makes towers for wind turbines. After wasting all that fuel, President Obama stressed the need to cut carbon pollution: "But the bulk of our efforts must focus on unleashing a new, clean-energy economy that will begin to reduce our dependence on foreign oil, will cut our carbon pollution by about 80 percent by 2050, and create millions of new jobs right here in America."

If this liberal environmental hypocrisy sounds familiar, it should. Former Vice President Al Gore is a leader on the issue. After winning

the Oscar for *An Inconvenient Truth*, the Tennessee Center for Policy Research found that "Gore's mansion, located in the posh Belle Meade area of Nashville, consumes more electricity every month than the average American



household uses in an entire year ... In his documentary, the former Vice President calls on Americans to conserve energy by reducing electricity consumption at home... Since the release of *An Inconvenient Truth*, Gore's energy consumption has increased from an average of 16,200 kWh per month in 2005, to 18,400 kWh per month in 2006."

It turns out that Obama and Gore could learn a thing or two from a surprising source: Texas oilman and former President George W. Bush. In 2001, *USA Today* called his ranch an "eco-friendly haven."

Obama Administration Incompetence

During the campaign, President Obama promised to end the so-called incompetence of the Bush Administration. He also promised to get government working on behalf of the everyday American again. What happened over the New York City skyline on Monday morning calls these promises into question. On the eve of his 100th day in office, in a stunning display of incompetence, the Obama Administration caused a panic in New York City by authorizing a low-altitude "flying photo op" of one of President Obama's 747s over Manhattan! According to the *Wall Street Journal*: "As a result, to onlookers Monday all across downtown Manhattan - where the World Trade Center once stood - the photo shoot looked like a terrorist attack. Sebelius Is 6th Obama Nominee With Tax Problems!

Former Kansas Governor Kathleen Sebelius, President Obama's nominee for Secretary of Health and Human Services (HHS), was confirmed by the Democrat-controlled U.S. Senate on Tuesday. Sebelius was confirmed despite the fact that she failed to pay her taxes accurately, and apparently misled the Senate Finance Committee about questionable campaign contributions. Earlier this month it was reported that "an audit of her and her husband's 2005, 2006, 2007 tax returns has revealed some 'unintentional errors, which we immediately corrected.' As a result, Sebelius and her husband have filed amended returns and paid \$7,040 in back taxes and \$878 in interest." Astonishingly, Sebelius' tax disclosure marks the sixth Obama nominee in the first 100 days to admit to not paying their taxes accurately.

More recently, Sebelius was forced to amend answers she submitted to the committee regarding political contributions she received from Dr. George Tiller, a late-term abortion




But in addition to those campaign donations, records reviewed by *The Associated Press* show that Tiller gave at least \$23,000 more from 2000-2002 to a political action committee Sebelius established while insurance commissioner to raise money for fellow Democrats."



The saga continued on April 23 when Sebelius vetoed Kansas Senate Bill 218 "The 2009 Late-Term and Partial-Birth Abortion Regulation Act." Sebelius vetoed the bill despite polling indicating that seventy-five percent of the American people think the procedure of late-term abortion should be illegal. April 29, 2009 marked the 100th day of the Obama Administration.
