Guantanamo Inmates Returning to Battlefield

President Obama's reckless decision to close Guantanamo Bay prison before having a plan for the jailed terrorists is continuing to haunt the inexperienced Commander-in-Chief. A shocking report recently released by the Defense Department indicated that one in seven prisoners released from the Guantanamo detention facility have returned to the battlefield!

According to the report, "Based upon a comprehensive review of available information as of mid-March 2009, the Defense Intelligence Agency reported 14 percent as the overall rate of former Guantanamo detainees confirmed or suspected of reengaging in terrorist activities... Various former Guantanamo detainees are known to have reengaged in terrorist activity associated with the al-Qaeda network, and have been arrested for reengaging in terrorist activities including facilitating the travel of terrorists into war zones, providing funds to al-Qaeda, and supporting and associating with known terrorists."

The report in question was released on May 26th, but was delayed because the Obama White House was fearful of its political consequences. According to a *New York Times* story published on May 20th, "Two administration officials who spoke on condition of anonymity said the report was being held up by

Who is Sonia Sotomayor?

Defense Department employees fearful of upsetting the White House, at a time when even Congressional Democrats have begun to show misgivings over Mr. Obama's plan to close Guantanamo."

of the court on issues such as abortion and gay marriage. Sotomayor's pride in her own judicial activism is a cause for concern. At a forum at Duke University in 2005, Sotomayor brazenly stated that "the court of appeals is where policy is made." The video shows Judge Sotomayor quite at ease with the idea that it's appropriate for members of the judiciary to make law instead of interpreting it.

The choice of Judge Sotomayor is also disappointing because she made a racially divisive statement in the recent past that didn't seem to bother President Obama during the vetting process. During a 2001 speech at a California Berkeley Law School symposium, Sotomayor stated "I would hope that a wise Latina woman with the richness of her experiences would more often than not reach a better conclusion than a white male who hasn't lived that life." Judge Sotomayor was opining on Justice Sandra Day O'Connor's line that "a wise old man and wise old woman will reach the same conclusion in deciding cases." Apparently Sotomayor does not agree with the notion that race and gender should have nothing to do with how one interprets the Constitution.

The best point about this statement was made by former House Speaker Newt Gingrich. What would happen if a white male Supreme Court nominee made the same statement about a Latina woman? There would undoubtedly be calls forcing that nominee to withdraw.

As the confirmation process moves forward, it is important that Democrat leaders who control the hearing schedule on Capitol Hill allow time for a thorough examination of Judge Sotomayor's record. President Obama and Vice President Biden want to rush Sotomayor's confirmation and have the vote before the August recess. This is hypocrisy at its finest as Obama and Biden were both in favor of filibustering Justice Samuel Alito's nomination in 2006.

Stimulus Bill Spin

The U.S. economy is now officially the Obama economy. President Obama and his team demonstrated this by going on a full blown public relations offensive to mark the 100 day anniversary of his stimulus bill becoming law. Unfortunately, the details being released by the Obama Administration are contradictory, short on facts, and exaggerated.

President Obama continues to make the claim that the bill has created or saved 150,000 jobs, but on the same day, his chief economic adviser Christina Romer relayed a very different message: "The gold standard is going to be jobs numbers. And realistically, we're not going to see us adding jobs for a while." Even *The New York Times* has reported that the 150,000 jobs claim is tough to back up: "some economists have questioned the administration's claims that



the bill has saved or created 150,000 jobs."

According to the U.S. Bureau of Labor Statistics, since the Obama stimulus bill was enacted, the United States has lost over 1.2 million jobs. The reality is that President Obama completely oversold the bill's impact when he promised it would create or save millions of jobs over the next two years. The National Association for Business Economists recently estimated that about 4.5 million jobs will be lost in 2009 alone! According to *Reuters*, "Peter Morici, an economist and professor at the University of Maryland, said the Obama administration was overselling the gains from the stimulus."

It also appears that stimulus funds are not being sent to the states that need it most, which was one of President Obama's main objectives

Source Document Center: President Obama Should Fire Harry Knox

On April 6th, President Obama announced the appointment of Harry Knox to the President's Advisory Council on Faith-Based and Neighborhood Partnerships. The President made this appointment despite the fact that Knox has a history of making anti-Catholic statements. According to Fox News, "Harry Knox, director of the religion and faith program at Human Rights Campaign, a Washington-based gay rights group, lambasted the prelates in a gay newspaper last month for their support of Proposition 8, the successful November ballot measure that made same-sex marriage unconstitutional in California. Knox told the Bay Area Reporter that the Knights of Columbus, the Catholic fraternal service organization, were 'foot soldiers of a discredited army of oppression' for their role in the campaign, saying

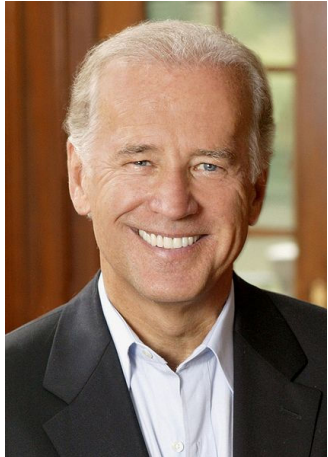
the group 'followed discredited leaders,' including bishops and Pope Benedict."

In response to Knox's appointment and statements, a group of Catholic leaders from around the country, including House Republican Leader John Boehner (R-OH) and Congressman Thaddeus McCotter (R-MI), released a letter demanding that President Obama remove Harry Knox from his post. The letter states in pertinent part: "As Catholics, we call on you to remove Mr. Knox from his position and to formally disassociate yourself from his militant anti-Catholicism. Failure to do so will result in the tainting of your Faith-Based Council - and indeed, your entire administration - as anti-Catholic."

for economic recovery. According to *USA Today*, "Nationwide, federal agencies have awarded nearly \$4 billion in contracts to help jump-start the economy since President Obama signed the massive stimulus package in February. But, with few exceptions, that money has not reached states where the unemployment rate is highest...In Michigan, for example — where years of economic tumult and a collapsing domestic auto industry have produced the nation's worst unemployment rate — federal agencies have spent about \$2 million on stimulus contracts, or 21 cents per person. In Oregon, where unemployment is almost as high, they have spent \$2.12 per capita, far less than the nationwide average of nearly \$13."

President Obama has also failed to fulfill his promise to allow Americans to monitor how their billions in taxpayer dollars are being spent. According to *The Washington Post*, "to build support for the stimulus package, President Obama vowed unprecedented transparency, a big part of which, he said, would be allowing taxpayers to track money to the street level on *Recovery.gov*...But three months after the bill was signed, *Recovery.gov* offers little beyond news releases, general breakdowns of spending, and acronym-laden spreadsheets and timelines. And congressional Democrats, state officials and advocates of open government worry that the White House cannot come close to clearing the high bar it set."

Partisan Stimulus Bill Coming Back to Haunt Liberals

It Depends What The Definition Of “Lobbyist” Is

If you ask the Obama White House, they’ll tell you they’ve only had to issue a few waivers to permit lobbyists to work in their Administration. Seemingly, every time you turn on the television, someone from the liberal media is trumpeting how tough President Obama has been on lobbyists by pointing to the executive orders he issued on his first day in office. After reading the orders, it’s clear that President Obama was very careful with the language, as most of the rules revolve around two year restrictions:



“If I was a registered lobbyist within the 2 years before the date of my appointment...I will not for a period of 2 years after the date of my appointment: participate in any particular matter on which I lobbied within the 2 years before the date of my appointment...or seek or accept employment with any executive

agency that I lobbied within the 2 years before the date of my appointment.”

If President Obama truly believes that lobbyists are the root of all evils in Washington, why not increase the number of years or ban lobbyists completely?

A little noticed report issued by *National Journal* contains the answer: “National Journal checked the names of 267 individuals appointed or nominated to various senior positions in the Obama administration against the Senate Office of Public Records database of registered lobbyists...

This chart lists the names of 30 individuals, or about 11 percent of the total, who were registered to lobby at some point within the past five years.”

Is President Obama being genuine in his actions to prevent lobbyists from working in his Administration? Before making a judgment, be sure to read the fine print.

President Obama Praises Pelosi Despite CIA Swipe

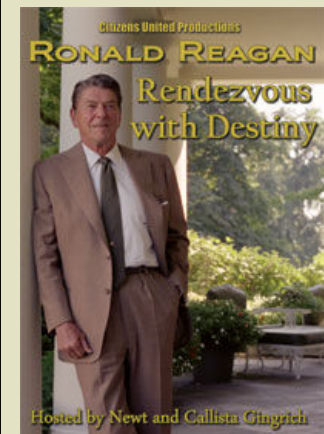

We've all noticed that coverage of the war in Iraq has dropped off over the last year or so. Ever since it became an incontrovertible truth that the Bush Surge worked, The *New York Times* and MSNBC seem to have decided that there wasn't much worth covering anymore. Now that things are going better in Iraq and controversies are more difficult to create, it doesn't merit the coverage it once did. This phenomenon, while unfortunate, is not the most egregious failure of the mainstream media in covering the war in Iraq. Focused as they were for the last five years on finding reasons to blast President Bush for anything that happened in Iraq, the reporters tasked with covering the conflict missed some of the most incredible acts of courage and sacrifice that have ever been performed.

Sadly, the trend in Hollywood has mirrored the mainstream media. In a sad contrast to the epic films from fifty years ago showing the heroic GI vanquishing the evil Nazi, those in control of Hollywood today seem to revel when Americans face setbacks and dismiss any sign of progress. Major studio film projects have been almost uniformly shrill in their anti-war message, reflecting the usual Hollywood liberal fallacy that their views are representative of what the rest of the country believes.



Last spring, I was in Los Angeles where I had the privilege of seeing a trailer for a documentary entitled *Brothers At War*. *Brothers At War* was written and directed by Jake Rademacher, a filmmaker who

followed two of his brothers as they deployed to Iraq. It occurred to me that for all the ink that has been spilled about the causes and conduct of the war in Iraq, up until that point there had not been a documentary film that really captured the essence of what it is like to be a combat soldier in Iraq. A film had not yet been made to show something that your average Hollywood liberal doesn't understand: while there is plenty of disagreement over the war itself, it is close to impossible to find an American citizen who is not proud of the men and women in the military and their service to this country.
